Today more than ever Christian Scientists have the opportunity to engage in the healthcare revolution.



# SUNLAND MEMBERSHIP BYLAWS

*Following is an excerpt from the BYLAWS of SUNLAND HOME FOUNDATION:*

## ARTICLE I NAME

- 1.1 The name of this organization, a benevolent non-profit organization, incorporated under the laws of the State of California, December 8, 1944, shall be SUNLAND HOME FOUNDATION.

## ARTICLE II PURPOSE

- 2.1 The purpose of Sunland Home Foundation shall be to provide Christian Science Nursing Services for those relying on Christian Science treatment for healing; such services to be in accordance with the Manual of The Mother Church, The First Church of Christ, Scientist, in Boston, Massachusetts, by Mary Baker Eddy.

## ARTICLE III MEMBERSHIP

- 3.1 Who Are Members. The members of Sunland Home Foundation are those whose applications for membership have been accepted by the Board of Directors and who retain membership eligibility and pay annual dues prior to the Annual Meeting of the Foundation.
- 3.2 Eligibility. To be eligible for membership, an applicant must be a member of The Mother Church, The First Church of Christ, Scientist, in Boston, Massachusetts, or of a branch of The Mother Church.
- 3.3 Application Procedure. Anyone desiring to become a member of Sunland Home Foundation shall submit an application together with dues for the current year to the Secretary of the Foundation.
- 3.4 Admission. The applicant shall become a member upon acceptance by the Board of Directors.
- 3.5 Duties. It shall be the duty of members to attend membership meetings and to support the Foundation metaphysically and financially.
- 3.6 Dues.
  - 3.6.1 Dues as established by the Board of Directors shall be due and payable annually on January 1.
  - 3.6.2 Dues for new members accepted after October 1 shall be applied to the following year.

Dues and contributions to SUNLAND HOME FOUNDATION may be considered for tax deductible purposes.
